Senqu Local Municipality wishes to invite bids for provision of protective clothing and accordingly invites bidders to apply for evaluation and listing as accredited service providers for a period of 3 years.

The closing date for submission of applications is at **12h00 on 30<sup>th</sup> of June 2017** and applications must be placed in sealed envelopes and clearly marked "**Provision of Protective Clothing – Notice No: 72/2017**" and delivered to the offices of the Municipality at 19 Murray Street, Lady Grey and placed in the tender box.

A compulsory clarification meeting will take place on **Wednesday, 21 June 2017**. Tenderers are required to meet the Municipal Representatives at **10h00** at the **Senqu Municipal Offices, 19 Murray Street, Lady Grey**.

1. The Municipality requires protective clothing as prescribed in annexure A and in accordance with the safety requirements as prescribed in the relevant legislation.
2. An original valid Tender Tax Clearance Certificate or the SARS PIN must be supplied with the tender or else the tender will not be considered
3. Central Supplier Database registration PIN number must be submitted for verification
4. A consolidated Tax Clearance Certificate and bank account will be required if the winning bidder is a consortium or joint venture before any payments will be made.
5. Current Municipal Billing Clearance Certificate. No contract will be awarded to an applicant who is in arrears (or who fails to make suitable arrangements to settle the arrears) in respect of municipal rates and other charges due to the

Municipality or the municipality in whose jurisdiction its offices are located. If a municipal account is not available, a signed copy of the lease contract with a confirmation letter from the owner of the property that confirms in writing that the rental is paid up to date, or a letter from the Councillor of Headman in your village which states that the bidder does not pay rates and taxes and must indicate bidder's name, ID no and address.

6. All prices must include VAT, delivery to Senqu Local Municipality, Lady Grey Offices and must be valid for at least 120 days.

Samples of all the required items must be must be submitted to the Senqu Municipality Offices in Lady Grey **before 7<sup>th</sup> of July 2017, 12h00** on all items or Tender will not be considered.
