The following conditions will apply:

- No faxed or e- mailed quotations will be accepted, only a hand delivered or courier sealed tenders.
 - Canvassing of municipal staff will automatically disqualify any tender.
 - **Tender Documents to be evaluated must be collected and be returned from Senqu Municipal Offices at own cost, this must be included in the tender rate.**
 - All legislative compliance must be checked and must be part of the evaluation report.
 - A current Tax Clearance certificate or SARS Pin number must be submitted.
 - A copy of the CSD registration must be submitted – please ensure that you are Tax compliant.
 - All prices must be VAT inclusive
 - The municipal rates and taxes or municipal charges owed by the preferred bidder or any of its directors to the municipality or municipal entity, or to any other municipality or municipal entity, are not in arrears for more than three months. Proof must be submitted in the form of a municipal account or letter of good standing.
 - The Successful candidate/company will be required to register on the Senqu Municipality Data base.
 - Tenders must be valid for a minimum of 60 days from date of closure.
 - The tenders will be evaluated on the 80/20 preference points system as prescribed in the PPPFA; these documents will be available on the Senqu Municipality website - [www.senqu municipality.gov.za](http://www.senqu.municipality.gov.za))
