Senqu Municipality Supply Chain Management Policy as well as the following conditions shall apply:

- Canvassing of municipal staff or councillors will automatically disqualify any tender.
- The tender must be bound with own documents and all SCM documents and tender advertisement.
- The tender must be bound with the tender biding checklist as the first page of the document with the completed page numbers.
- A current Tender Tax Clearance Certificate (original) must be supplied with the tender or else the tender will not be considered.
- All prices must include VAT.
- The municipal rates and taxes or municipal charges owed by the preferred bidder or any of its directors, to the municipality or municipal entity, or to any other municipality or its entity, must not be in arrears for more than three months. Proof must be submitted in the form of a recent municipal account or letter of good standing.
- If a municipal account is not available, a copy of the lease contract with the confirmation from the Owner of the property that confirms in writing that the rental is paid up to date.
- The successful bidder will be required to register on the Senqu Municipality data base.

- Prices must be valid for a minimum period of 120 days.
- The tenders will be evaluated on the 80/20 preference points system as prescribed in the PPPFA; these documents will be available on the Senqu Municipality website – www.senqumunicipality.co.za
- Preferential Procurement Regulation 2011 (B-BBEE) principles will apply, whereby a tenderer's submission will be evaluated according to the sum of the Award of Points in respect of the tender value and the status of the enterprise
 - Adjudication criteria are as follows:
 - □ 80 Points for Price
 - 20 Points for B-BBEE status level of Contribution




Front View

Office Electrification requirements:

Each office must have two double Plugs with one light supported by a light switch.

Distribution board must also fitted in one Office which then will supply all three Offices Plugs and Lights.

Distribution board must consist of an Earth leakage unit 63amp with three 20amp circuit breakers supplying the Plugs and one 10amp circuit breaker supplying all three lights.

Wiring of the plug circuits and the lights is compulsory by Contractor with an Electrical Compliance Certificate. (COC)

Material to be used to build the offices:

For the construction of the offices use 100mm by 100mm wooden frames.

For the covering purpose use 2,7m by 1,8m by 16mm Supa Wood panels

Panels must be screwed together with wooden screws and Frame must be paneled both sides.

Framework must be 50mm by 76mm SABS Per lines in order to secure firmness of the structure.

Roof must also be closed inside and outside.

Paving

Floor size of Paving is 50 mm²

Specifications:

Segmented paving blocks required.

Must be interlock paving blocks.

Concrete block paving (35mPa, type SA 80mm high) works include the cut of the pavers to fit edge restraints.

Paving color must be grey.

Provision and spray of approved herbicide and ant poison.

Removal of small trees and permission must be obtained from Senqu Municipal Tourism Department.

To obtain information if the trees is indigent or protected. In this case Paving must be made around the indigent or protected threes if it is the case.

Clear and grub for preparation of top layer.

Rip and compact of the top soil layer before the laying of the paving blocks.
