WASTE MANAGEMENT

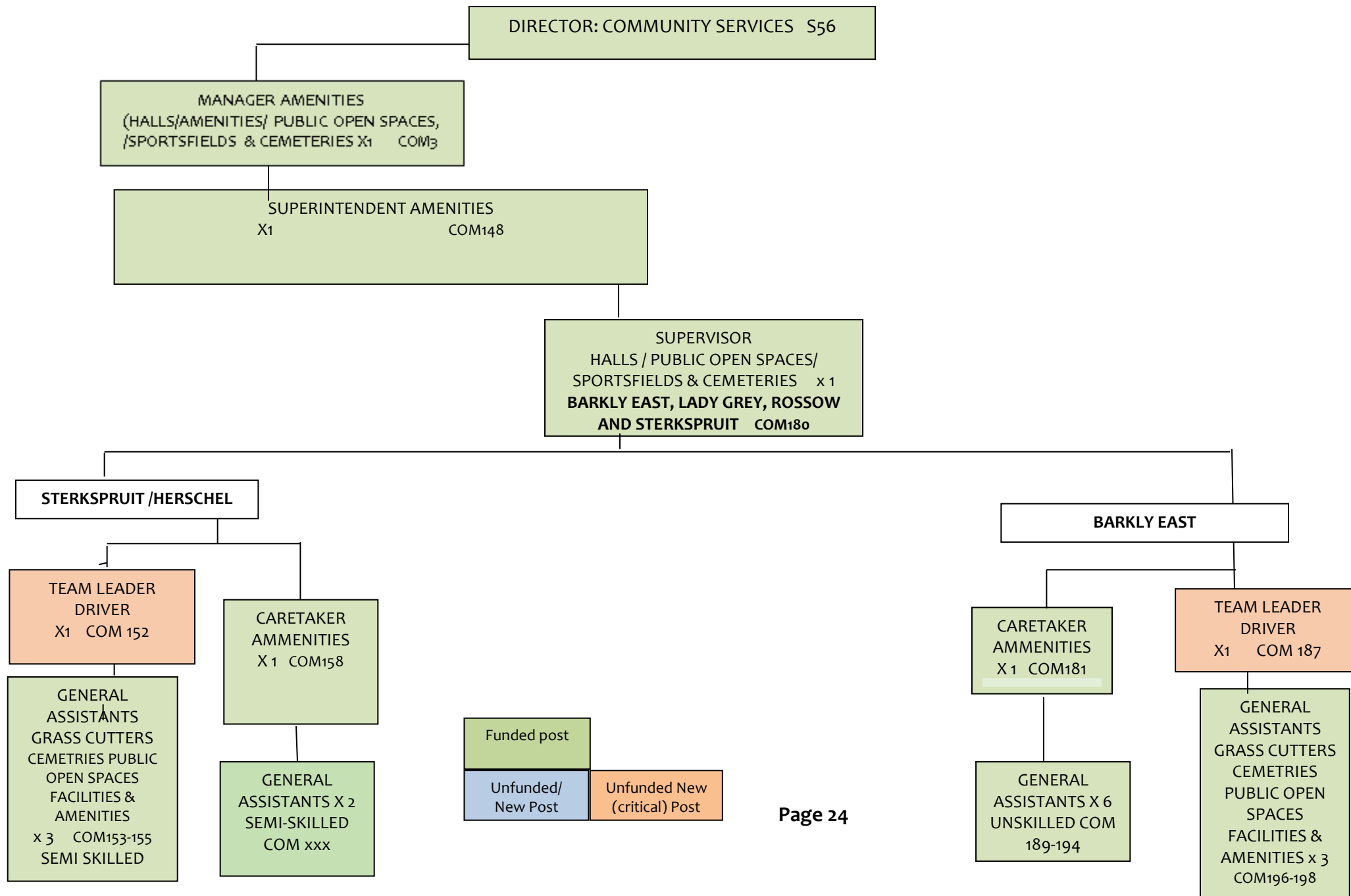
